EVENT FIRING ORDER:

NRA 1800 Approved Precision Pistol Match followed by an optional CMP EIC practice match.

RULES: Current NRA Outdoor Precision Pistol Rules shall govern.

ELIGIBILITY: NRA membership is not required, but is encouraged.

Juniors shall be 12 years of age or older.

CLASSIFICATION: NRA classification system shall apply.

SQUADDING: All matches will be squadded. Older Shooters will be squadded closer to the range access door.

SCORING: Scoring shall be performed by competitors. Score plug use by Match Officials only. All challenges shall be made before the target change. **Challenge fee: \$2.00ea. (proceeds go to Junior Rifle Team).**

AWARDS: Cash awards using rule of 5. Small classes will be combined.

ENTRY FEE (NRA): \$25.00 per competitor.

(New shooters may shoot .22 across the course if range space allows. Fee \$25.00)

ENTRIES: Advance entries are **requested**. Post entries will be accepted until the match begins. Match will be limited to one relay of 22 shooters. Please arrive before 08:45.
